ALL PREMIUM OILFIELD SUPPLY LTD. PRODUCTS ARE SOLD OR OTHERWISE FURNISHED IN ACCORDANCE WITH THESE **GENERAL TERMS AND CONDITIONS**.

PREMIUM OILFIELD SUPPLY LTD (POSL) WARRANTS THE PRODUCTS SOLD BY IT TO BE FREE FROM DEFECTS IN MATERIAL AND WORKMANSHIP FOR A PERIOD OF **(1) YEAR** FROM DATE OF SHIPMENT FROM POSL. POSL WILL REPAIR OR REPLACE AT POSL'S OPTION, ANY PRODUCTS WHICH POSL DETERMINES TO BE DEFECTIVE IN MATERIAL OR WORKMANSHIP, PROVIDED THAT POSL IS GIVEN PROMPT NOTICE IN WRITING OF ANY DEFECT; AND PROVIDED BUYER OR USER HAS KEPT SUCH PRODUCTS IN CONDITION WHERE POSL CAN EXAMINE SAME; AND PROVIDED NO MACHINING, WELDING, HEATING, OR UNAUTHORIZED ALTERING OF ANY KIND IS DONE TO SAID PRODUCTS AFTER SAME ARE PERFORMED OR SHIPPED FROM POSL'S FACILITIES. IN NO EVENT SHALL POSL BE LIABLE FOR INCIDENTAL, CONSEQUENTIAL, SPECIAL OR OTHER DAMAGES OF ANY NATURE. IT IS EXPRESSLY AGREED THAT **THIS WARRANTY SHALL BE IN LIEU OF ANY OTHER WARRANTY, EXPRESSED OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY FOR MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE.**
